RESOLUTION #165 - offered by Boyette, seconded by Rodgers

Resolved to accept the bids from Auctions International as follows: 1985 Military generators \$470.00: 1990 International Dump Truck \$5000.00; 2006 Ford F250 Pick up \$570.00; and 2009 Military Freightliner \$20,800 for a total of \$26,840.00 Ayes 5, Nays 0

Hector Hamlet Boundaries & Reduced speed limit: DOT is asking for boundaries of the Hamlet of Hector; median speed from study was 54 mph. Discussion of North of Ball Diamond at Walsh Road south to Bond Smith Park Road. Three blind curves in that distance along with firehouse, post office, church and Dandy along with residences and businesses.

<u>Water District</u>: Superintendent Stapleton reported the following: Water testing up to date, leak in T-1 skid tank to be plastic welded; both trucks back in service; RFP's on new well and extension will be presented at January 14, 2020 meeting.

<u>Code Enforcement</u>: Officer Santobianco reported December has been a slower month; 3 permits issued; inspections continuing; Dandy progressing with construction; Sheriff's Office called him out on a Town of Dix residence Christmas Eve for a melted outlet; Fire Department could not leave without Code Enforcement checking hazard and determining if the structure was safe.

Town of Montour has no Code Officer and has asked Jason for assistance; he is willing to help out on a temporary basis until they find someone. Supervisor White and Supervisor Scott from Montour may discuss a Shared Services agreement for the future.

Smith Park: Supervisor White has asked Janine to submit reports for the annual financial audit meeting.

Town Clerk/Tax Collector:

Ag & Markets completed a Shelter and DCO Inspection in Schuyler County; everything was satisfactory.

Supervisor:

Video or Audio recording of meetings discussed: most public want live streaming; that presents its own set of concerns; no equipment has been ordered at this point; further research will be done. Resident who brought this up has purchased live streaming equipment; plans to live stream zoning commission meetings and will be in touch to offer assistance.

Discussion of information that could be clarified for people regarding budget, processes, bills, Town Boards responsibility and duties, etc. Government structure discussed.

NYC Association of Towns Conference: Discussion regarding who is interested in going or not; transportation by bus, multiple cars, or rental vehicle. Number of rooms needed will depend on who's going.
