<u>S.Yezzi</u> provided and reviewed the following attached documents Summary of the priority exercise from all (4) public meetings (2 pages) Public Comment sheet from all (4) public meetings (1 Page) Copy of mapping exercise from all (4) public meetings (4 pages)

- <u>S.Yezzi stated the following topics and assumptions were the top (3) from all (4) public meetings</u> depicted in the summary:
- 1) Water Quality Maintain good water quality for Seneca Lake and other public water sources (i.e. aquafers, wells)
- 2) Residential Living Differentiate areas where low-and high-density housing should exist
- 3) Natural Resources Conserve parklands, National Forest, areas where the Town would like to preserve natural features, or where greater slopes exist.

K.Cusolito stated the importance of taking a broad perspective when considering Hector land use regulations. We need to look forward - generations - in the future and not get hung up on every detail and comment.

Zoning Commission, as a group, participated in an exercise of initially defining land use areas on a map of Hector. Topics included in this exercise were, Hamlet Revitalization, Preservation, Agricultural, High Density Residential and Commercial Development
